Introduction

The objective has been to ensure a uniform professional standard in respective supervisory developmental activities. An annual examination is conducted under the scheme and the syllabus primarily concentrates on the practical applications of the theoretical principles. The examination has been widely accepted and at present is being conducted in English and Hindi. So far 75000 candidates registered for the certificate.

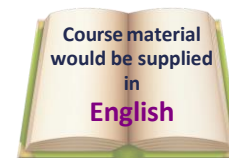
